

# Privacy statement

May 2018

OPENPLUS SYSTEMS B.V., a company registered in The Netherlands with registered number 64821560, along with its subsidiaries, divisions, and affiliates ("Batchforce"), understands the importance of protecting and safeguarding your privacy when you use our website. This Privacy Statement tells you about the information Batchforce may collect on this website, how the information is used, and how you can access and correct certain information that we may collect.

If you as a visitor choose to register or submit information to Batchforce via this website (the "Site"), you agree to the use of such data in accordance with this Privacy Statement. Please note that this Site contains links to other websites, including, without limitation, websites maintained by Batchforce, and other affiliated entities of Batchforce. Also note that the Batchforce may use third parties to host all or portions of, or to assist in maintaining, the Batchforce websites.

If you have any questions regarding this Privacy Statement, or do not feel that your concerns have been addressed, please direct your questions to us using the appropriate email link set forth in the "Contact" section below.

- 1. Collection of Your Personal Data.** You can access many areas of our Site without submitting any personally identifiable data. You may voluntarily choose to provide Batchforce with identifiable personal data by completing forms, sending emails, or other means as may be provided from time to time on the Site. The personally identifiable data that we would collect from you if you so choose would typically include your name and title, email address, mailing address, telephone and information about your company. In addition to information that you voluntarily submit, Batchforce may, at its option, collect additional information about you from third party sources. Personal data collected by Batchforce will be as reasonably necessary to fulfil your requests and to provide the most relevant, targeted offers and information from Batchforce. All such information collected shall be referred to herein as "Personal Data".

Furthermore, Batchforce monitors incoming and outgoing Site traffic data to help diagnose problems with its servers and to administer its Site. Batchforce also uses this data to assemble broad demographic information about its visitors, customers, and partners in general .

The following is a list of examples where you may choose to specifically and voluntarily submit Personal Data to Batchforce through this Site, which Batchforce may use for each purpose indicated at the time of your submission:

2. **Use of Your Personal Data.** Batchforce uses Personal Data submitted through the Site to provide a way for customers, partners, customer and partner prospects, and other contacts to communicate with our team. Batchforce collects the Personal Data from you in order to establish and maintain relationships, and in order to serve you better. When appropriate, Batchforce may also use the Personal Data separately or in combination with pre-existing information.

By voluntarily submitting your Personal Data, you consent to the collection and use of your Personal Data as described in this Privacy Statement. In some circumstances, Batchforce may share Personal Data that you voluntarily submit with trustworthy business partners. We will only use such third party business partners in order to deliver services to us or on our behalf, and they are prohibited from using that information for any other purpose.

Personal Data collected on this Site may be stored and processed in any country in which Batchforce (or its affiliates, subsidiaries, and divisions and their respective third party business partners and suppliers) maintain facilities. This may include transfer to countries without data protection rules similar to those in effect in your country of residence. You acknowledge and agree that by providing Personal Data to Batchforce through this Site, you consent to the transmission of such Personal Data over international borders as necessary for processing your requests.

Due to the existing legal, regulatory, and security environment, Batchforce may be required, under certain circumstances, to disclose aggregate level and/or personally identifiable data submitted to Batchforce through the Site. Batchforce will use reasonable efforts to limit such disclosures to the following circumstances: (i) where Batchforce believes in good faith that it is required to do so in response to a subpoena or other legal process; (ii) where reasonably required to do so in order to maintain, update or otherwise implement Batchforce's data security measures, equipment, technical operations and the like; (iii) where reasonably necessary to identify, contact, or bring legal action against persons or entities to preserve and/or enforce Batchforce's rights, including but not limited to enforcing the Terms of Use for this Site; (iv) protect and defend the rights or property of Batchforce; or (v) in urgent circumstances to protect the personal safety of the public or of users of the Batchforce products, services, and the Site.

In addition, Batchforce may also disclose Personal Data in connection with the sale,

assignment, or other transfer of the Batchforce business or any part thereof, or as part of a security audit.

- 3. Protection of Your Personal Data.** Batchforce undertakes substantial efforts to protect the confidentiality of the Personal Data, preferences and other information it has collected through this Site and will never knowingly allow access to this information to anyone outside Batchforce other than as described herein. Batchforce has made a substantial investment in its server, database, backup and firewall technologies to protect the information assets of the Batchforce network, including the confidentiality of Personal Data collected through this Site. These technologies are deployed as part of a sophisticated security architecture and protocol.

You should also do your part in protecting your information. Your Batchforce username and any password (if such is provided or enacted) are confidential, and we recommend that you not divulge them to anyone. Unfortunately, due to the nature of the Internet as a public transmission network, neither Batchforce's network nor data transmission over the Internet can be guaranteed to be 100% secure. As a result, while we strive to protect Personal Data that is transmitted to us by you, Batchforce cannot ensure or warrant the security of such information. Thus, any Personal Data transmitted to us is done so at your own risk. Once we receive Personal Data, Batchforce undertakes substantial efforts to protect the confidentiality of this information consistent with this Privacy Statement.

- 4. Cookies.** If you review or download information, we may track the visit through the use of "cookies". Cookies are pieces of information that a website transfers to an individual's hard drive for record-keeping purposes. The use of cookies is an industry standard, and you will find cookies at most major websites. Cookies help Batchforce to tailor information to your preferences and to see which areas of the website are frequented most. Batchforce never uses cookies to retrieve information from your computer that was not originally sent in a cookie. Most browsers are initially set to accept cookies. If you prefer, you can change your browser settings to refuse cookies. However, in so doing, you may not be able to fully utilize the Site.
- 5. Web Beacons.** Pages on this Site may contain electronic images referred to as Web Beacons and also sometimes referred to as single-pixel gifs or clear gifs. The Web Beacons may be used to assist in delivering cookies throughout our Site to track the number of users and Site activity tracking purposes.
- 6. Links to Other Websites.** This Site may contain links to websites which are owned and operated by third parties and do not operate in accordance with this Privacy Statement. When you link to other websites through this Site, this Privacy Statement and our privacy practices no longer apply. We encourage you to review each website's privacy policy before disclosing any personally identifiable information. Batchforce is not responsible for the privacy practices of such third party websites.
- 7. Choices Regarding Use of Personal Information.** Upon voluntarily providing your Personal Data to Batchforce through this Site, Batchforce will use your Personal Data

in accordance with this Privacy Statement. Should you at any time decide that you do not want to continue to receive electronic communications, you will have the ability to unsubscribe or “opt out” from such communications by means of a link provided in each such communication to the preference center, or if not provided therein, by sending an email or contacting us at the contact details provided in the “Contact” section of this Privacy Statement.

8. **Corrections, Access and Updates to Your Personal Information.** Batchforce aims to keep your Personal Data as accurate as possible. Should you at any time desire to review, correct or update your Personal Data, you may update your relevant profile or registration (when applicable) or contact us using the contact information outlined in the Contact section below; Batchforce will comply with such requests as soon as commercially reasonable or determined by statutory law. In order to ensure the safety of Personal Data, please note you will be subject to providing sufficient evidence of your identity at the time of any such request before any Personal Data records will be made available by Batchforce.
9. **Data Retention.** The Personal Data that you submit to Batchforce will only be retained for as long as required for the purposes for which it was collected or as required by law. Our retention of your Personal Data allows Batchforce to continue to provide you with highly personalized services without interruption.
10. **Changes to this Privacy Statement.** Batchforce reserves the right to change this policy at any time and without prior notice to you. Your continued use of the Site following the posting of changes to these terms will mean you accept those changes. Batchforce will take reasonable measures to notify you if there is a material change in our privacy practices with respect to use of the information you have provided to Batchforce. Batchforce will conspicuously post these changes in our Privacy Statement. Batchforce also will post a message on the homepage of its Site that states that the Privacy Statement has been changed, and will provide a link to the Privacy Statement.
